**JOHN VAUGHAN MAYOR'S LETTER**

Well school is finally out for most of the kids and the days are getting longer. Please be very careful when driving through the city. The posted speed limit is 25 mph on all roads in the city except for Herr Lane and Westport Road. Also, make sure you come to a full stop at all stop signs and use caution when passing the occasional parked car, walkers and bicyclists.

Speaking of stop signs, Council member Dave Beaudoin and City Engineer Mark Madison have been working very hard negotiating the best possible price for the installation of new street signs throughout the entire city. The new signs and posts will be very similar to the signs installed last fall along Herr Lane. Dave and Mark should have the details worked out and a contract awarded by the end of June.

The Council is currently finalizing the budget for the next fiscal year starting on July 1<sup>st</sup>. At this time it looks like the tax rate will remain the same with a discount similar to last year's 9 % discount for prompt payment. The street sign project, city office renovation, and purchase of a new police vehicle are the major expenditures included in the new budget.

A few projects are nearing completion under this year's budget. The trees at the Fairmeadows and Ormsby Lane entrance that were damaged during the ice storm have been removed. The gravel will be removed from the center traffic island and grass planted in its place. The police department completed their implementation and training to use body cameras. So smile when talking to the officers you never know who may be watching.

I would like to thank this year's Garden Tour organizer, Ted Wright and our nine resident families that were a part of the tour. We had a record number of gardens and viewers this year. In addition to several gardens showing off new additions to their gardens, we had several families join the tour for the first time. I would like to thank Brownsboro Hardware for setting up their Big Green Egg and serving bbq to garden visitors. Also, a special thanks goes out to Sandy Frederick, our Master Gardener, for being on hand to answer questions.

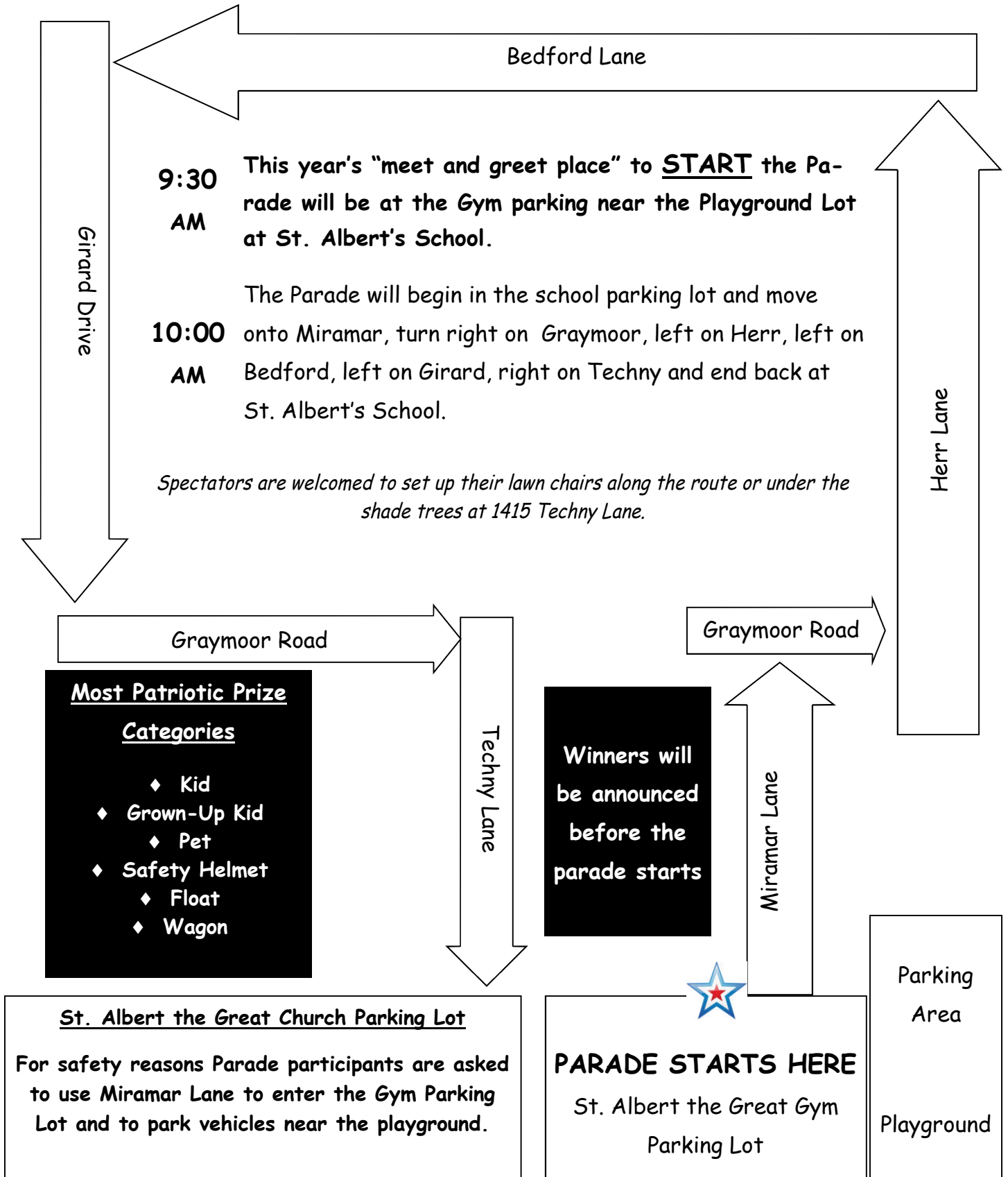

**SUMMARY OF CITY OF GRAYMOOR-DEVONDALE  
ORDINANCE #5, Series 2014-2015  
JOINT CODE ENFORCEMENT BOARD**

The City made two changes to its Code Enforcement Board Ordinance, changing the date of the regular meeting of the Code Enforcement Board to accommodate the schedules of the Board and staff and also adding specific language to allow the Board to also hear Alcohol Beverage Control (ABC) license violation appeals. The changes sections are set out below:

**4. ORGANIZATION; MEETINGS**

Regular meetings of the Code Enforcement Board shall be held on the third Thursday Wednesday of every month at the hour of 6:30 p.m. Meetings other than those regularly scheduled shall be special meetings held in accordance with the requirements of the Kentucky Open Meetings Act. If there is no business to come before the Board, the Chairman may cancel the meeting.

**6. JURISDICTION; POWERS**

The Code Enforcement Board shall have jurisdiction to enforce and shall enforce those city ordinances and code provisions which specifically provide for Code Board Enforcement; both within the City of Graymoor-Devondale and within any city which has in place an Interlocal Cooperation Agreement to perform and enforce the duties of a code enforcement board. The Code Enforcement Board shall also have jurisdiction to review and hear appeals from the enforcement actions of the Local Alcohol Beverage Control (ABC) Officer for enforcement under KRS Chapters 241 through 244; including suspensions and revocation of licenses under KRS 243.480 and KRS 243.490. In all such ABC cases, the Code Enforcement Board's action shall be a detailed finding of fact and recommendation to the Local Alcohol Beverage Control Administrator, who may adopt, modify or reject said recommendation and issue the final order. The final order of the Local ABC Administrator may be appealed to the state ABC Board, as set out in KRS Chapters 241 through 244.

**10. APPEALS; FINAL JUDGMENT**

An appeal from any final order of the Code Enforcement Board may be taken to the Jefferson County District Court within 30 days of the date the order is issued. The appeal shall be initiated by the filing of a complaint and a copy of the Code Enforcement Board's order in the same manner as any civil action under the Kentucky Rules of Civil Procedure. ABC cases may only be appealed to the State ABC Board as set out in KRS Chapters 241 through 244.

**12. LIEN, FINES, CHARGES AND FEES**

The only penalties which may be considered under ABC cases are those found in KRS Chapters 241 through 244; including license suspension and revocation under KRS 243.480 and KRS 243.490. □

**SBA Disaster Loan Outreach Centers in Kentucky to Close**

**ATLANTA** –The U.S. Small Business Administration announced today that due to a steady decrease of activity, it’s Disaster Loan Outreach Centers (DLOCs) in Louisville, Kentucky will close in the coming days. The DLOC at the Okolona Fire Protection District House will close on Thursday, June 4 at close of business. The DLOC at the Beechmont Community Center will close on Thursday, June 11 at close of business. Disaster survivors interested in obtaining low-interest disaster loans are encouraged to visit the Centers before they cease operations.

Survivors referred by FEMA to the SBA may apply for disaster loan online using the Electronic Loan Application (ELA) via SBA’s secure website at <https://disasterloan.sba.gov/ela> or visit the nearest recovery center. More information may be obtained by calling the SBA’s Customer Service Center at 800-659-2955 (800-877-8339 for the deaf and hard-of-hearing) or by sending an email to [disastercustomerservice@sba.gov](mailto:disastercustomerservice@sba.gov). **Being a Good Neighbor in Graymoor-Devondale - Things You Need To Know and Do**

**Speed Limit**

The posted speed limit for all city streets is 25 mph. Additionally, when traveling along Westport Road you should remember, the center lane is for turns only. The Graymoor-Devondale Police Department will issue citations to drivers that use the center lane inappropriately.

**Parking (on and off street)**

It is illegal to park a vehicle on any street within Graymoor-Devondale in excess of four (4) hours. Vehicles can only be parked on paved, graveled or similar hard surfaces. Vehicles should remain on the pavement. Tires should not be parked on the grass along any street.

It is illegal to park, store or maintain any disabled vehicle, boat trailer, camper, recreational vehicle, mobile home, bus or motor truck > 1.5 ton load capacity on any public or private property in a residential area unless the vehicle is behind the front wall of the residence on a hard durable surface.**Home Improvements**

Contact the City Clerk at ([cityclerk@graymoor-devondale.com](mailto:cityclerk@graymoor-devondale.com)) or call the City Office before starting any exterior home improvement project. It is the resident’s responsibility to confirm if permits or variances are required from Graymoor-Devondale.

Examples of projects that require a permit include home additions, sheds, garages, and fences. Failure to obtain the required permit may delay, alter, or stop your project until the required permit is received from the Graymoor-Devondale Code Enforcement Officer.

### **Pet Nuisances**

Residents are expected to be respectful of our City and other residents and should ensure their pet is a welcomed member of our community. When walking their (leashed) dogs, residents are expected to carry bags and remove any waste left by their dog.

Cats are not allowed to roam into other residents' yards.

***Dog and cat owners are expected to keep their pet on a leash or on the owner's property.***

Pet nuisance issues are not addressed by the Graymoor-Devondale Police Department or governed by Graymoor-Devondale Ordinances. Pet nuisance issues are addressed only by calling Metro Animal Control at 502-363-6609. Metro Animal Control's actions are usually to pick up and remove the pet. The pet's owner is then required to pick up their pet and pay all fees due Metro Animal Control.

### **Nuisances**

Graymoor-Devondale, by ordinance, addresses certain nuisances such as tall grass and weeds, accumulation of rubbish, trees or shrubbery that obstruct streets, sidewalks or drainage, keeping of animals and junk (scrap metal and cars).

Residents are responsible for maintaining the appearance of their home and yard. Failure to do so may result in citations and fines issued by the Graymoor-Devondale Police Department.

### **Yard Waste**

Yard waste must be in open containers or paper bags. Limbs or branches should be tied in manageable bundles no longer than three (3) feet and placed at the curb the night before your scheduled Waste Management System pick-up day. Unbundled items will not be picked up. *Remember, yard waste in regular plastic bags will NOT be picked up by Waste Management.*

### **Trash Containers**

Trash containers should be placed at the curb after 6:00 PM on the day before the Waste Management System's pick-up day. Residents are expected to remove and properly store trash containers from the curb no later than 5:00 PM the day after pick-up.

### **In-Home Businesses**

Our City has placed limitations on home-based businesses in residential dwellings; no merchandise for retail sale, no more than 10% of the living space in a home can be used for a business, customers must park on the driveway of the home, no outside or visible to the exterior advertising is allowed.

### **No Soliciting**

Commercial solicitation is by permit only. This includes door to door and passing out flyers. For your safety, please do not allow any Commercial Solicitor into your home until you have verified they have our City's required permit. If a resident suspects a Commercial Solicitor does not have the required permit, please call the Graymoor-Devondale Police Department.

Residents are encouraged to ask Commercial Solicitors to contact Graymoor-Devondale's City Clerk to request the required permit. Please note, permits issued by any other city or agency do not meet Graymoor-Devondale's permit requirements.

Advertising on residential property is prohibited.

### **Signs**

Contractors and vendors are not allowed to post signs in our city. Should a plumber, painter or window company work at your home, they are not allowed to leave signage in your yard.

Advertising on city easements and residential property is prohibited. The Graymoor-Devondale Police Department may issue citations and fines to those that violate this ordinance.

### **Homestead Exemption**

Property owners who are 65 or older are eligible to receive the Homestead Exemption on their primary residence. If you are eligible, the exemption amount is subtracted from your property's assessed value, reducing your property tax liability. Only one exemption is allowed per household. The Homestead Exemption applies to your Jefferson County and Graymoor-Devondale tax liability. For information, contact the Jefferson County PVA Homestead Department at 574-6380.
